



Sms2mobiz Terms of Service

By using the sms2mobiz.com web site (“Service”), or any services of Version-Next Private Limited (“Version-Next”), you are agreeing to be bound by the following terms and conditions (“Terms of Service”).

Version-Next reserves the right to update and change the Terms of Service from time to time without notice. Any new features that augment or enhance the current Service, including the release of new tools and resources, shall be subject to the Terms of Service. Continued use of the Service after any such changes shall constitute your consent to such changes. Violation of any of the terms below will result in the termination of your Account. While Version-Next prohibits such conduct and Content on the Service, you understand and agree that Version-Next cannot be responsible for the Content posted or send using the Service and you nonetheless may be exposed to such materials. You agree to use then Service at your own risk.

Account Terms

1. You must be 13 years or older to use this Service.
2. You must be a human. Accounts registered by “bots” or other automated Methods are not permitted.
3. You must provide your legal full name, a valid email address, and any other information requested in order to complete the signup process.
4. Your login may only be used by one person – a single login shared by multiple people is not permitted. You may create separate logins for as many people as your plan allows.
5. You are responsible for maintaining the security of your account and password. Version-Next cannot and will not be liable for any loss or damage from your failure to comply with this security obligation.
6. You are responsible for all Content posted/send and activity that occurs under your account (even when Content is posted/send by others who have accounts under your account).
7. If you are using a free account you are not permitted to block ads.
8. One person or legal entity may not maintain more than one free account.
9. You may not use the Service for any illegal or unauthorized purpose. You must not, in the use of the Service, violate any laws in your jurisdiction (including but not limited to copyright laws).

API Terms

Customers may access their Sms2mobiz account data via an API (Application Program Interface). Any use of the API, including use of the API through a third-party product that accesses Sms2mobiz, is bound by the terms of this agreement plus the following specific terms:





1. You expressly understand and agree that Version-Next shall not be liable for any direct, indirect, incidental, special, consequential or exemplary damages, including but not limited to, damages for loss of profits, goodwill, use, data or other intangible losses (even if Version-Next has been advised of the possibility of such damages), resulting from your use of the API or third-party products that access data via the API.

2. Abuse or excessively frequent requests to Sms2mobiz via the API may result in the temporary or permanent suspension of your account's access to the API. Version-Next, in its sole discretion, will determine abuse or excessive usage of the API. Version-Next will make a reasonable attempt via email to warn the account owner prior to suspension.

3. Version-Next reserves the right at any time to modify or discontinue, temporarily or permanently, your access to the API (or any part thereof) with or without notice.

Payment, Refunds, Upgrading and Downgrading Terms

1. A valid credit card is required for paying accounts. Free accounts are not required to provide a credit card number.

2. **You may also pay via bank Cheque, Demand Drafts or Money Transfers to MobMe Wireless Private Limited.**

3. **The Service is billed in advance on a monthly basis and is non-refundable There will be no refunds or credits for partial months of service, upgrade/downgrade refunds, or refunds for months unused with an open account. In order to treat everyone equally, no exceptions will be made.**

5. For any upgrade or downgrade in plan level, your user account that you provided will automatically be charged the new rate on your next billing cycle.

Cancellation and Termination

1. **You are solely responsible for properly canceling your account. 2. If you cancel the Service before the end of your current paid up month, your cancellation will take effect immediately and you will not be charged again.

3. Sms2mobiz Privacy Policy

We collect the e-mail addresses and mobile numbers of those who communicate with us via e-mail, aggregate information on what pages consumers access or visit, and information volunteered by the consumer (such as survey information and/or site registrations). COOKIES
